Unified electronic visa

From August 1, 2023, citizens of 55 countries, the list of which was approved by the decree of the Government of the Russian Federation of October 6, 2020. No. 2571-r (attached), it became possible to issue a single electronic visa valid throughout the territory of the Russian Federation.

An electronic visa is issued on the basis of foreign citizen's application filled out in electronic form on a specialized website. The Ministry of Foreign Affairs of the Russian Federation (MFA Russia) by the following link: <https://electronic-visa.kdmid.ru> or via mobile application, the link to which can be found on the specialized website.

A single electronic visa gives the right to a single entry into the Russian Federation and stay for guest or business purposes as well as a tourist. Moreover, it allows guests to participate in scientific, cultural, socio-political, economic, sports events.

An application for a single electronic visa must be submitted no later than 4 calendar days before the expected date of entry into the Russian Federation. A photo and a copy of foreign citizen's passport are attached to the application. To obtain a single electronic visa invitations, hotel booking confirmations or any other documents confirming the purpose of the trip are not required.

The validity period of a single electronic visa is 60 days from the date of its registration with the permitted period of stay of a foreign citizen in the Russian Federation no more than 16 days from the date of entry into the territory of the Russian Federation.

Payment of the consular fee in the amount of 52 US dollars is made online on the mentioned website of the MFA Russia.

Thus, entry into the Russian Federation by foreign citizens of countries that are included in the approved list using a single electronic visa is the most preferable option, since the procedure for its registration is simplified as much as possible: it takes place completely on the Internet and does not require a visit to the Russian consulate
