Rules of conduct for accredited persons at the venue of the XVII International Economic Forum "Russia – Islamic World: KazanForum" 2026 in Kazan

During participation in the Forum events, Accredited Persons shall:

1. Comply with public order and the requirements set forth in these Rules while at the Forum venue;
2. Undergo a personal inspection and provide personal belongings for inspection when passing or driving through the Forum venue and/or into the adjacent territory;
3. Comply with legal requirements of the Organiser, Security Personnel, and federal executive authorities involved in ensuring security;
4. Hand over bulky items with dimensions of more than 40x40x45 cm to the storage room, except in cases where the carrying of bulky items to the Forum venue is agreed upon with the Organiser;
5. Avoid actions that could lead to extreme situations and create danger for surrounding persons;
6. Immediately inform federal executive authorities involved in ensuring security and maintenance of public order and public security at the Forum venue about detection of suspicious objects, violation of public order, appearance of smoke or fire, or necessity to provide medical assistance to persons present at the Forum venue;
7. Refrain from causing property damage to the Organisers, Accredited Persons of other client groups of the Forum, the general contractor, Security Personnel, and federal executive authorities involved in ensuring security; treat the property of the Forum venue with care, and maintain cleanliness;
8. Show respect to the Organisers, Accredited Persons of other client groups of the Forum, the general contractor, Security Personnel, and federal executive authorities involved in ensuring security;
9. Refrain from leaving minor children unattended;
10. Park vehicles in specially designated areas;
11. When informed about evacuation from the Forum venue, act in accordance with the instructions (orders) of Security Personnel and federal executive authorities involved in ensuring security, in accordance with fire safety requirements and the approved evacuation plan, keeping calm and refraining from panicking;
12. Refrain from attending the Forum if showing signs of an acute respiratory viral infection (cough, body temperature above 37 degrees Celsius).

Accredited Persons are not allowed to the following at the Forum venue:

1. Perform actions that threaten personal security, life, health, as well as the security, life and health of other persons at the Forum venue or in the adjacent territory;
2. Bring prohibited items and substances, firearms and cold arms, stabbing, cutting, as well as other items that can be used to cause bodily harm, pyrotechnic products, flammable, poisonous and substances irritating the mucous membranes of the human body, alcoholic beverages, beer, drinks and products in glass and metal containers, in plastic containers over 0.5 liter; large packages, bags, suitcases and other items that interfere with other Accredited Persons, as well as with the conduct of the Forum;
3. Throw objects in the direction of Accredited Persons present at the Forum venue or in the adjacent territory;
4. Drink alcoholic beverages or appear in public places under the influence of alcohol or narcotic substances;
5. Insult other persons (including through the use of banners, posters, signs and other means of visual propaganda) and perform other actions that discredit the honor, dignity or business reputation, or that

- are aimed at stirring up hatred or hostility, as well as humiliating the dignity of a person or a group of persons based on gender, race, nationality, language, origin, or attitude to religion;
6. Interfere with the movement of Accredited Persons and vehicles; climb fences, parapets, lighting devices, platforms for television filming, trees, roofs, supporting structures and other constructions not intended to accommodate people;
 7. Damage equipment and design elements of structures;
 8. Make inscriptions and drawings on structures, buildings, facilities located at the Forum venue, or place foreign objects near them without a relevant permit of the Organiser or the general contractor;
 9. Hide their faces, including through the use of masks, except for cases specially provided for by the Organiser, as well as in cases of using elements of religious attire;
 10. Violate public morals and standards of behavior by exposure of intimate body parts while at the Forum venue;
 11. Enter the Forum venue or the adjacent territory without an Accreditation Card, or enter areas of the Forum venue access to which is limited by the Organiser and/or the general contractor without an Access Card;
 12. Stay on staircases during the Forum, obstruct movement in areas of the Forum venue intended for evacuation, including passageways, exits and entrances (main and emergency);
 13. Come to the Forum venue with animals and birds, except for guide dogs in muzzles;
 14. Hold public events not mentioned in the Forum programme;
 15. Engage in illegal trade (including selling entrance tickets or documents that replace them), distribute in any manner products of a political, religious or racist nature (including posters, leaflets, booklets);
 16. Use unmanned aerial vehicles, except for the use of unmanned aerial vehicles by law enforcement agencies, as well as by the Organisers, with advance registration of approval and obtaining of permit, and notification of the employees of the federal executive authorities involved in ensuring security who are on duty.
