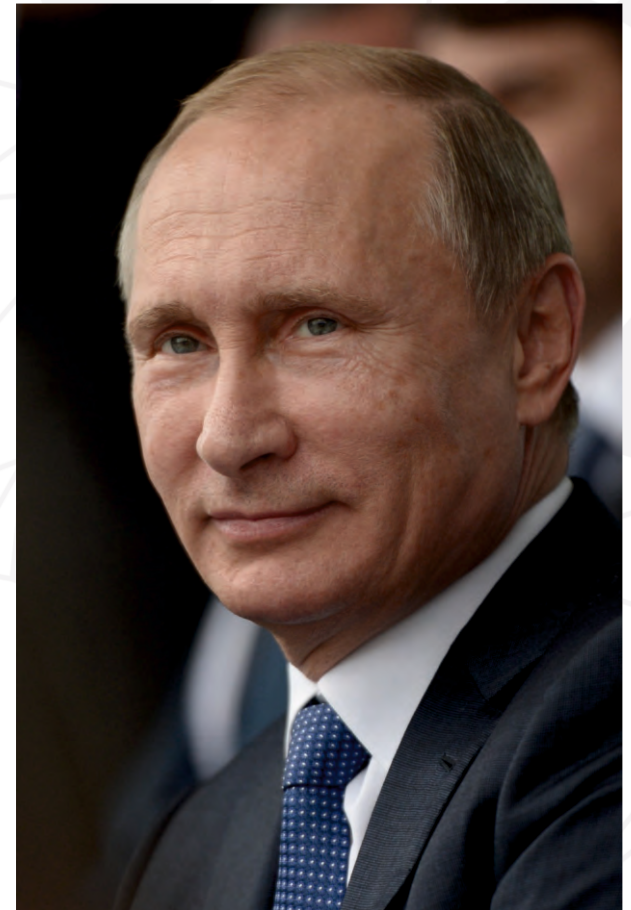
I would like to note that Tatarstan is one of the regions of the Russian Federation that is most actively building such fruitful and constructive relationships.

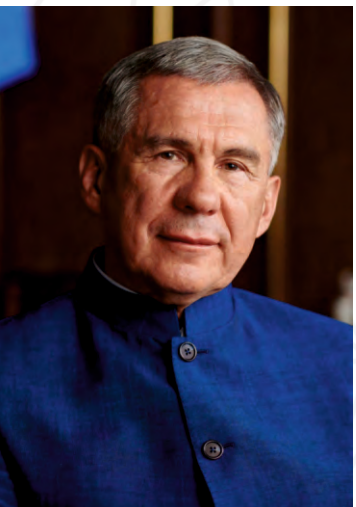
