

The economy is going through a period of deep structural transformation. This requires significant financial resources. We are actively developing new instruments that can be used, among other things, to finance projects for technological modernization of the economy. The development of partner financial instruments in Russia could become an additional investment vector.

Starting September 1, 2023, we launched a two-year experiment on the use of such instruments in four regions: the Republic of Bashkortostan, the Republic of Dagestan, the Republic of Tatarstan and the Chechen Republic. The experiment will help determine the scale of demand for such services among market participants and facilitate their availability for Russian citizens as well as small and medium-sized businesses.

In addition, partner financial instruments may create conditions for attracting foreign investment and expanding the geography of foreign trade.






