

Quotation and procedure for participation of representatives of foreign official delegations in the International Economic Forum "Russia – Islamic World: KazanForum"

Heads of delegations must send to the Organizing Committee the composition of representatives for participation in the Forum.

Foreign official delegations headed by the Ministers of the countries	1+1	3
Foreign official delegations headed by other officials	1	2

For official delegations represented at the level of heads of State and Government, the decision on quotas is made by the Organizing Committee on an individual basis.

Official delegations that have facilities (business areas, meeting rooms), as well as those planning to hold events at the Forum venue, additional technical badges can be issued to ensure the operation of facilities and business areas and procedures for signing agreements. The access level of the technical badges corresponds to the location of the object or negotiations.

Participants who have the status of a speaker are not counted in the delegation quota.

Meeting rooms and individual transport are provided at the expense of the sending party.

Quotas for the participation of representatives of the constituent entities of the Russian Federation in the International Economic Forum "Russia - the Islamic World: KazanForum»

Heads of constituent entities of the Russian Federation send the composition of representatives to the Organizing Committee to participate in the Forum.

Heads of the constituent entities of the Russian Federation are invited by order of the Government of the Russian Federation.

- Each region has a subject head quota:
- basic quota for participation of the head of a constituent entity of the Russian Federation without registration fee: **2 Premium packages + 3 Standard packages;**
- basic quota in case of refusal of the head of a constituent entity of the Russian Federation without registration fee: **1 Premium package + 2 Standard packages;**
- basic quota for participation of the head of Investment Promotion Agency without registration fee: **1 Standard package;**
- basic quota for participation of the head of the Trade and Commerce Chamber of a constituent entity of the Russian Federation: **1 Standard package.**

Representatives of organizations subordinate to the authorities of the constituent entities of the Russian Federation, as well as representatives of the constituent entities of the Russian Federation in excess of the established quotas participate in the Forum on a paid basis. Participation of representatives of municipal authorities of constituent entities of the Russian Federation is on a paid basis. Participation of representatives of municipal authorities of constituent entities of the Russian Federation is on a paid basis.

Cost of participation* in the Forum for organizations subordinate to the authorities of the constituent entities of the Russian Federation, as well as representatives of the constituent entities of the Russian Federation:

- **Premium Package - 50 000 rubles (is not subject to VAT);**
- **Standard Package - 25 000 rubles (is not subject to VAT).**

Cost of participation in the Forum for representatives of Chambers of Trade and Commerce of constituent entities of the Russian Federation:

- **Standard package - 3 000 rubles (is not subject to VAT).**

For constituent entities of the Russian Federation that have facilities (business area, meeting rooms), as well as those planning to hold events at the Forum venue, additional technical badges can be issued to ensure the operation of facilities and business areas, as well as procedures for signing agreements. In the latter case, access to the site is limited by the date of the signing ceremony. The access level of technical badges corresponds to the location area of the object.

In case of refusal of the participation of the head of the constituent entity of the Russian Federation, the quota for the participation of the Investment Promotion Agency does not change.

Participants who have the status of a speaker are not counted in the delegation quota. In exceptional cases, by the decision of the Organizing Committee, participation quotas may be expanded.

Quotas for participation of representatives of federal executive authorities of the Russian Federation in the International Economic Forum "Russia - the Islamic World: KazanForum»

The heads of federal executive authorities of the Russian Federation (hereinafter referred to as FEA) are invited by order of the Government of the Russian Federation. The heads of the FEA send representatives to the organizing committee to participate in the Forum.

Quota of Deputy Prime Ministers of the Russian Federation: **2 Premium packages + 3 Standard packages.**

FEA quota with the participation of the head: **2 Premium packages + 3 Standard packages.**

The quota of FEA in case of refusal of the participation of the head: **2 Standard packages**

Representatives of the FEA in excess of the established quotas participate in the Forum on a paid basis.

Cost of participation* in the Forum for FEA:

- **Premium Package - 50 000 rubles (is not subject to VAT);**
- **Standard Package - 25 000 rubles (is not subject to VAT).**
